He had not yet received an update. d) South Ayrshire Health & Social Care Locality Planning Partnership (SAHSCP LPP): CS did not attend on 11th December - main items as follows: Presentation on AILN (Ayrshire Independent Living Network): Discussion on microenterprises and availability of small grants until 2026 to start a new business. Locality Plan: New format for meetings commencing in February- 1 theme each meeting. PB Funding Evaluation: Mentors provided if required to successful applicants – after 6 and 12 months on from receiving funding. Community Engagement: 53 attended on 22nd November. Discussion on Social Housing needs was prioritised. Girvan Hospital Review: Eye screening clinic opening date – hopefully in January. Ayrshire Urgent Care Service: From 16th December Girvan Hospital is now providing the 'Out of Hours' bed cover, formerly provided by GPs. ACk expressed extreme dismay, shared by all, that the GPs were no longer providing cover. Situation to be monitored. Updates: SC First Responders: Fewer hours of cover due to illness. Carers: cAyr Fest to be held on 22nd February in Ayr. Recent lack of ambulance cover in Girvan affecting cardiac arrests was much regretted. 	It was noted that the formal Consultation phase is due to end on 14 th February 2025, which is the closing date for responses. The planned 'Drop-in' session scheduled for 10 th December 2024 had been postponed until 21 st January. CS and KMcL were among attendees. This was not as other consultations, with no display boards or paper copies of the survey form available – most disappointing. ACk informed of SAC's recent decision to support the proposed National Park, with conditions. These included responsibility for planning applications, with SAC rejecting any dilution of local authority powers, wanting to keep these in-house. The Local Plan and the normal application process should be adhered to. A discussion ensued with some scepticism as to how much notice would be taken of these conditions. The proposed name was also discussed. It was agreed that individual survey responses should be made.	ALL
